Gallery Rules:

Welcome to Dove Gallery. Dove Gallery offers several exhibition opportunities and an Art Competition each year. Artists are encouraged to submit their artwork for consideration. Submissions can be done in person with Curatorial Staff or by email to dove@parkvictoria.org. Submissions should contain a signed copy of the Gallery Rules, a completed Exhibit Form (fully describing each piece of art and whether it is equipped for hanging) and an image of the artwork(s). Curatorial staff (Current: Rob Carroll and Carol Hamilton) reserve the right to decide which artworks will be in the final exhibit. Adult Artists, Youth and Children 6 years of age and over are encouraged to apply. All participants agree to be included in any media coverage arranged for the event.

Artists who do not deliver their artwork to the Gallery by the Notification date may forfeit their space in the exhibit. Artwork may be delivered at times listed in the Notification or by appointment with Carol Hamilton (408) 464-5011. Please make sure to write your email address and phone number legibly so that Notification can be made. All Artwork must remain in the Gallery for the duration of the exhibit.

The Gallery is for exhibit only. No sales will be brokered through gallery staff or take place at the gallery site.

This is a publicly accessible space. All exhibitors hereby agree that neither the church, the gallery nor its staff will be liable for damaged, lost, or stolen art. Exhibitors are encouraged to secure their own insurance for the exhibit period if desired.

To promote community, the gallery will allow visitors to leave messages for artists who are on display. Staff is not responsible for screening these messages. A parent can decline to have messages relayed on their child's artwork by initialing here: _____

Removal of artwork must coincide with the scheduled times. Artwork left at the gallery 7 days beyond scheduled pick-up may be left on the doorstep of address provided by the exhibitor or discarded at the discretion of gallery staff.

A limited number of frames are available for works that are not currently equipped for hanging. Please indicate if your work is not currently "ready-to-hang" and gallery staff will try to accommodate you.
